Online Privacy & Data Protection

Privacy and data protection were in focus during Global Conference on Cyberspace (The Hague, 16-17 April).

Trend towards wider access to Internet data by governments: US officials considering technical options to allow them access to encrypted data on smartphones or other devices through a digital key; both parties in UK election race pledging to extend powers of security agencies; French Intelligence Bill set to increase powers of intelligence services.
