on the occasion of the 47th session of the Human Rights Council:

“The role of the Human Rights Council in promoting a human rights-based approach to new and emerging technologies”

Date: 15 June 2021; 3 – 5pm CET

Co-organizer: Core Group on new technologies (Republic of Korea, Austria, Brazil, Denmark, Morocco, Singapore); OHCHR

In his “Call to Action on Human Rights”, UN Secretary-General Guterres identified new and emerging technologies as a new frontier for human rights. He called for the development of a human rights-based „framework“ for the digital space, following-up on the recommendations of the High-Level Panel on Digital Cooperation.

Within the framework of the Human Rights Council and its special mechanisms, numerous resolutions, publi-

cations, and recommendations have emerged in recent years addressing the impact of new technologies on specific rights (right to privacy, freedom of association, freedom of expression, children’s rights, economic/social/cultural rights). In 2019, the HRC adopted a resolution tasking its Advisory Committee to develop a global perspective on the issue and to identify options for action for the HRC. The report will be presented to the HRC at its 47th session in June 2021.

Objectives:

- Raising Awareness: Exchange between states, tech-companies and UN agencies in the run-up to the Human Rights Council.
- Taking stock of challenges and opportunities for the full realization of the existing human rights framework for new/digital technologies.
- Reviewing and discussing the Advisory Committee’s report on the possible impacts, opportunities and challenges of new and emerging digital technologies with regard to the promotion and protection of human rights and its recommendations
- Identifying challenges and issues that the HRC should address in its work.
