ICANN and New Domains	No major developments
<b>Online Privacy &amp; Data Protection</b>	UN Human Rights Council adopts resolution on the right to privacy in the digital age; decides 'to appoint, for a period of three years, a special rapporteur on the right to privacy'. Special Rapporteur to be named later this year.
Net Neutrality	Shift of dynamics from the USA in February (US FCC announcement) to the EU in March; EU Commissioner A. Ansip at the GSMA Mobile World Congress said net neutrality must be enshrined into EU law; in Brussels Commissioner A. Ansip said no difference between the EU approach and US FCC proposal; Council of the European Union to start negotiations with European Parliament on Net neutrality.
Jurisdiction	French court establishes jurisdiction over Facebook in the <i>l'Origine du Monde</i> case; court bases jurisdiction on plaintiff's domicile instead of the seat of Facebook (California).

Pressure on **China** regarding new rules for banking sector which require companies to hand source codes and encryption keys to government for security purposes.


